



## **"PwnThyBytes CTF 2019" CONTEST TERMS SHEET**

The **"PwnThyBytes CTF 2019"** contest, hereinafter referred to as the **"Contest"**, is offered by BITDEFENDER SRL, with the registered office having the address **15A Orhideelor St. Orhideea Towers, district 6 Bucharest, 060071, Romania**, registered in Bucharest town, under registration number **J40/20427/06.12.2005**, legally represented by **Florin Talpes**, as CEO, hereinafter referred to as the **"Bitdefender"**

### **A.1. CONTEST PERIOD**

The period when the Contest will take place (**"Contest Period"**) is between Saturday, 28 September 2019, 09:00 (**GMT + 3**) and Monday, 30 September 2019, 01:00(**GMT + 3**).

**A.2. Territory:** worldwide

**A.3. ENTRY.** For the registration in the Contest, the participants must follow the next steps:

Eligible participants may enter by registering at the landing page provided below and completing the tasks as detailed on the site during the Contest Period. Participants may enter only once. Participants may work in teams; however, the prize money will be awarded solely to the person whose email is listed on the team registration. It is the sole responsibility of the registrant to distribute any potential winnings. Bitdefender takes no liability for the distribution of payment to other group members.

Registration is open until the end of the Contest.

To be eligible to participate at the Contest, the Participants should not reside in a country under any current U.S. or EU Sanctions.

### **A.4. CONTEST MECHANISM**

The Contest is comprised of three main parts:

1. Registration, described in A.3.
2. Competition where participants have to solve as many challenges as possible in the allocated time. The competition is a Jeopardy style Capture the Flag Contest.
3. Write-Up submission - Teams have to submit the write-ups for the solved challenges no later than 72 hours after the End of Contest.

### **A.5. PRIZE INFORMATION**

Prizes are:

2048 EUR - first place

1024 EUR - second place

512 EUR - third place

The designated persons from the winning teams will have to provide their real names, address and bank account in order to receive their awards. The payment recipient is responsible for any transfer charge and for accessing the funds once transferred.



#### **A.6. WINNER SELECTION**

There will be a scoreboard where points will be assigned at the end of the competition based on the challenges that were completed. Each challenge will have an amount of points based on the number of teams that solved it. Winners will be selected based on the greatest number of points earned. In case of a tie, the team with the earlier submission of the last flag will be the winner.
